However, any cremation services or funeral arrangements you select will include a charge for our basic services of funeral director and staff. If legal or other requirements mean you must purchase any items you did not specifically ask for, the reason for the requirement of that item will be explained in writing on the statement we provide describing the funeral goods and services selected.

Basic Services of Funeral Director and Staff **\$300.00**

This is a basic fee that we charge every family for our professional service in assisting them with their preferences. It includes a proportionate share of our overhead required to serve the public. Our charge includes but is not limited to consultation with the family, administration and clerical services, preparation of the death certificate for certification of the attending physician or coroner, consultation with the cemetery or common carrier and our availability 24 hours to bring your loved one into our care. This fee for our basic services and overhead will be added to the total cost of the funeral arrangements you select. (This fee for our basic services and overhead is already included in our charges for direct cremation, direct burial, forwarding remains and receiving remains).

Transfer of Loved One into Our Care (within 25 miles) **\$200.00**

Transfer outside the normal service area will be calculated at \$4.00 per mile. This cost will be added to our transfer cost.

Professional Embalming **\$400.00**

Except in certain special cases, embalming is not a requirement by state law. Embalming may be necessary, however, if you select arrangements with viewing or if you wish to have your loved one to be dressed. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation, any service where there will not be an open casket at your service.

Refrigeration and care for your loved one while in our care (Required when embalming is not selected)	\$200.00
Dressing, Cosmetology and/or Casketing	\$100.00
Sanitary and Preparation for an Identification Viewing	\$100.00
Use of Facilities for holding of a casket or remains until funeral service is scheduled (no more than 3 days)	\$100.00
Post Autopsy or Restorative Care	\$300.00
Custodial Care (When family requests for loved one to be held more than 10 working days)	\$25 / per day

Funeral Services at Church or Facility and Graveside (Same Day) ** **\$600.00**

Includes the mortuary staff for the service and coordination of the service within our service area of *25 miles
Included is an In Memory register book and 60 standard memorial folders or standard prayer cards
This service is for casketed remains at the service with up to one hour of viewing prior to or at conclusion of service

***Additional cost for mileage will be added at \$4.00 per mile**

**** Saturday Services will have an additional cost of \$300.00**

Memorial Services at Church or Facility and Graveside (Same Day) ** **\$450.00**

Includes the mortuary staff for the service and coordination of the service within our service area of *25 miles
Included is an In Memory register book and 60 standard memorial folders or standard prayer cards
This service is for an urn with cremated remains or with no urn present

***Additional cost for mileage will be added at \$4.00 per mile**

**** Saturday Services will have an additional cost of \$300.00**

Graveside Service (Only) ** **\$300.00**

Includes the mortuary staff for the service and coordination of the service within our service area of *25 miles
Included is an In Memory register book and 60 standard memorial folders or standard prayer cards

This service is for a casket or an urn present at the graveside

***Additional cost for mileage will be added at \$4.00 per mile**

Visitation / Viewing

Our funeral home only offers Visitation or Viewing time prior to or at the conclusion of a service

Direct Cremation

If you want to arrange a Direct Cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The container we provide is cardboard. Valley of Peace does not offer a rental casket.

Our charges for a Direct Cremation with no ceremonies include Administrative and Professional Services of Funeral Director and Staff, Transfer of Loved One into our care, Refrigeration, and Cremation Fees (up to 250 lbs)

Direct cremation with container provided by purchaser (must meet state and crematory requirements)	\$579.25
Direct cremation with cardboard container	\$604.25

Our charges for a COMPLETE Direct Cremation (all inclusive) with no ceremonies include Administrative and Professional Services of Funeral Director and Staff, Transfer of Loved One into our care, Refrigeration, the cremation fee (up to 250 lbs) delivery of the cremated remains to family home with 25 mile radius of the funeral home, the alternative container, permit fee, DCA fee, 1 certified death certificate, minimum plastic urn and taxes.

Total Cost: \$648.00

An air tray, which is required by the the crematory, will be an additional cost for a person over 250 lbs
Additional cost will vary depending on the weight of the person at the time they are taken to the crematory

Direct Burial

Our charges for a Direct Burial with no ceremonies include Basic Services of Funeral Director and Staff, Transfer of Loved One into Our Care, refrigeration, dressing and casketing, delivery of casketed remains to cemetery (within our 25 mile radius from funeral home)

Direct Burial with casket provided by purchaser (must meet state and cemetery requirements)	\$1,000.00
Direct Burial with minimum cloth covered casket	\$1,300.00
Direct Burial with casket selected from our funeral home	\$1,000.00

Forwarding of Remains to Another Funeral Home (in U.S.) **\$1,450.00**

This includes: Basic services of Funeral Director and Staff, Transfer of Loved One into our care, Professional Embalming, Dressing and Casketing, Transportation to Burbank or Los Angeles International Airport, and Shipping Container (either a Combo Air Tray or Casket Air Tray for Casket). This charge does not include a casket, airline costs, funeral services, visitation or viewing.

Receiving of Remains from Another Funeral Home **\$800.00**

This includes: Basic services of Funeral Director and Staff, transportation from the Burbank or Los Angeles International Airport, use of facilities for holding (up to 3 days), transportation with utility vehicle to cemetery, and coordination for delivery of the casket to the cemetery. This cost does not include a funeral coach, graveside service, funeral service or any merchandise.
